

Rules and Regulations
BIKINI VILLAGE Contest:
"\$500 shopping spree"

1. CONTEST DESCRIPTION AND PARTICIPATION:

- 1.1 **Start Date:** The "\$500 shopping spree" will open on Monday, November 3, 2025, at midnight/00:00AM Eastern standard time("EST").
- 1.2 **Closing Date:** The Contest will end on Sunday, November 23, 2025, at 11:59pm Eastern time.
- 1.3 **Sponsor:** The Contest sponsor is Bikini Village (property of Boutique La Vie en Rose Inc.) ("**Bikini Village**").
- 1.4 **Eligibility:** Participants must reside in Canada and have reached the age of majority of their province at the time of their Contest entry. This Contest is not open to employees of Bikini Village, or their affiliated companies, their affiliated sponsors, their advertising and promotional agencies, any person who resides with any of these individuals, or any member of their respective families living under the same roof.
- 1.5 **How to Participate**
- 2 **Bikini Village website:** To be eligible to the Contest, participants must visit the contest page from the Bikini Village website: bikinivillage.com/contest and sign up to Bikini Village's newsletter to enter for a chance to win. Participants must complete the lead form by entering their email address to win. The participant can also enter by filling out the form available at Bikini Village stores, at the checkout. A participant's chances of winning vary based on the number of eligible participations received during the Contest period. Selected participant will have to answer a mathematical skill question.

2. THE PRIZES

- 2.1 **Prize:** One (1) prize will be awarded by Bikini Village throughout the contest.
- 2.2 **Prize includes** one (1) Bikini Village gift card, a value of \$500.
- 2.3 The Prize offered must be accepted as awarded and is not exchangeable, transferable or convertible into cash. If the Prize is not accepted in accordance with its attached conditions, the Prize will be deemed to be forfeited.

- 2.4 **Draw:** The Prize will be awarded via a random draw amongst all eligible contest entries received during the Contest period. The draw will take place on Thursday, November 27, 2025, at approximately 2:00 p.m., EST. The draw will take place in Montreal, Quebec. The odds of winning will vary based on the total number of eligible entries received during the Contest period.

3. GENERAL RULES

- 3.1 **Contacting the Winner:** The Winner whose entries have been randomly selected during the draw will be contacted via email, at the discretion of Bikini Village. Upon establishing contact with the Winner and taking care of the required formalities, the Winner will receive his/her prize. If Bikini Village is unable, within a deadline of two (2) business days following the draw, to reach the Contest participant whose entries were randomly selected, another Winner will be drawn at random within the next two (2) days for each participant that could not be reached.
- 3.2 **Alternative Prize:** Should Bikini Village be unable to award the Prize (or any part of it) for reasons beyond their control, Bikini Village reserves the right to award an equivalent prize of the same kind and of equal or greater value or, at its entire discretion, to substitute for the Prize (or a part of this Prize) an equivalent monetary amount. The Prize must be accepted by the Winner as is. Bikini Village will not be required to accept or make any substitutions or modifications, nor will it transfer or provide any cash alternatives to the Prize. Documents issued in the Winner's name is neither transferable nor modifiable. If the Winner is unable to accept the Prize, they will not receive a replacement prize or any form or kind of compensation.
